Terms and Conditions:

- 1. Eligibility.** This spiff program (“the Program”), is a limited time incentive available to eSentire e3 partners.
- 2. Program Period.** The Program begins on September 1, 2024 and ends on October 31, 2024 (“Program Period”).
- 3. Qualifying Sales.** A “Qualifying Sale” refers to the sale of an eSentire Managed Detection and Response (MDR) service and/or an OnDemand 24/7 Incident Response Service with a 4 Hour Threat Suppression that meets the following criteria:
 - a. The sale must be completed, with a signed contract within the Program Period.
 - b. The sale must meet the minimum ACV deal size, \$50,000.
 - c. The sale must be a minimum of 12 months in term and maintain contracted ACV for a 12-month term without termination rights.
 - d. One-time, professional service, and renewal deals are not eligible.
 - e. The sale must be a new logo for eSentire.
 - f. The sale must be registered and approved through the eSentire deal registration process in the eSentire partner portal. Agents with a Master Partner Agreement (Technology Service Broker or Technology Service Distributor) must register deals in compliance with the TSB/D/Agent agreement.

 - **\$50,000 - \$125,000 ACV deal: \$2,500**
 - **\$125,001 - \$500,000 ACV deal: \$5,000**
 - **\$500,001 + ACV deal: \$7,500**
- b. The maximum spiff payment per Qualifying Sale is \$7,500, regardless of the deal size.

5. Payment Process

- a. Spiff payments will be made to the Partner.
- b. eSentire will make best effort to award spiff payments within 30 days after verification and approval of the Qualifying Sale.
