Verizon Wireless (“**VZW**”) is pleased to announce the following special incentive (“**SPF**”) in connection with the Activation of Verizon 5G and 4G Business Internet plans. This SPF shall be available to Business Agents, also referred to herein as Agents pursuant to the terms of their Verizon Partner Program Master Services Agreement and the accompanying Program Documents (collectively, the “**Agreement**”).

- ii. processed by Agent in the Ordering System;
- iii. resulting in a confirmed installation and Activation;
- iv. during the SPF Period (defined below).

Except as otherwise noted above, the SPF will be paid relating to 5G or 4G Business Internet Activations, as applicable, on or after [July 1, 2024 through December 31, 2024](#) (“**SPF Period**”). The above-referenced SPF Amount for each associated Product Type/Plan ID (Feature Code)/Speed, only applies to the retail price in effect for each Product Type/Plan ID (Feature Code)/Speed as of [July 1, 2024](#) (such retail price is located in the Ordering System).

This SPF letter replaces any previous SPF letter containing the same products and services. The SPF will be subject to Chargeback per the terms of the Agreement. VZW further reserves the right to suspend, modify, or terminate this SPF at any time upon notice to the Agent.

VZW retains the right to not pay, or recoup if already paid, this SPF in the event of a mistaken payment, fraud or suspected fraud. This SPF will be paid along with Compensation on your eStatement.

All terms and conditions as set forth in the Agreement, including, without limitation to, those relating to the payment of Compensation, remain in effect. The capitalized terms used in this letter shall have the same meanings as set forth in the Agreement unless otherwise defined herein.
