BCN Standard Promotion Plan Value

- **All Standalone Connectivity Services:**
 - 2X Agent Bonus, 2X One-Time Customer Account Credit, or split 1X / 1X
- **All SDWAN, SASE, Network Monitoring, Managed Network Equipment:**
 - 3X Agent Bonus, 3X One-Time Customer Account Credit, or split
- **All BCN IP Voice Services**
 - 4X Agent Bonus, 4X One-Time Customer Account Credit, or split

Note: A qualifying account with multiple service types under the bonus plan will be paid the appropriate bonus amount for each service type within the bonus calculation.

Qualifying Sales Partners:

- All contracted BCN Telecom Sales Partners are eligible to participate.

Qualifying Accounts:

- Promotion is ONLY applicable to New BCN Customers after July 1, 2025.

- All IP Connectivity Services
